## THE COUNTY OF WILTSHIRE (VARIOUS ROADS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER (No.18) 2022 (Ref TTRO 8333)

Notice is hereby given that Wiltshire Council has made an Order to close temporarily, to all vehicles, the lengths of road specified in the Schedule to this notice.

The order is required to enable carriageway micro asphalt dressing and associated maintenance works and will be operative from the 14 November 2022 for a maximum period of 18 months. The closures are anticipated to be for up to 5 days but only when traffic signs are in position and only for so long as is necessitated by the works.

It is anticipated that advance signs will be deployed 2 weeks prior to the closure dates. Access will be maintained where possible although delays are likely due to the nature of the works.

Closures 1 – 11 are anticipated to take place between 14 November 2022 and 19 December 2022.

Closures 12 – 14 are anticipated to take place between 3 January 2023 and 17 February 2023.

- 10. **Bowds Lane, Brinkworth, Tockenham, Lyneham and Bradenstoke**; from its junction with C120 to its junction with A3102.
- 11. **A420 (Part), Chippenham Without**; from its roundabout junction with A350 to its junction with Broad Lane.
- 12. **C414 (Part), Purton and Lydiard Millicent**; from its junction with Battlewell to its junction with C28.
- 13. **B4528 (Part), Chippenham and Lacock**; from its junction with B4643 to its roundabout junction with A350.
- 14. **A342 (Part), Charlton**, **Wilsford, Marden and Chirton**; from its junction with Friday Lane for a distance of approximately 4.7km in a north westerly direction.
